2. I/we hereby undertake to confirm that my / our exhibits and goods will strictly be restricted to the space allotted to me/us. If it is found that I/we am /are violating the norms, the Exhibition Society has the right to confiscate the goods beyond my / our allotted premises, levy penalty / cancel the allotment of stall /stalls.
3. I/we hereby undertake that I/we will get the goods / stall / pavilion insured against the theft, fire, hazards, disasters, natural calamities, arson, loot, riot or any other cause.
4. I/we hereby undertake to install fire extinguishers in my/our stall at my/our own cost and I / we may be held responsible for any fire mishap if occurs in my / our stalls.
5. I/we hereby undertake to state that the Exhibition Society shall not be held responsible / liable for any loss, damage or accident to our stall / property / employees from fire, theft, arson, loot, riot, natural calamities, disasters or any other cause, whatsoever.
6. I/we hereby undertake to assure the Exhibition Society that I / we make my / our own arrangements to protect from natural disasters / calamities such as harsh weather and rains during the exhibition period.
7. I/we hereby undertake to assure the Exhibition Society that I/We shall not file any suit or other proceedings against the Exhibition Society or any of the office bearers or members of the Managing Committee or employees of the Society for any act done or purported to be carried out under the provisions of Rules and Regulations, without first seeking redressal from the Managing Committee.

9. I am not permitted to put rings and any other things outside the stalls, if found, a penalty of Rs.50,000/- including GST & Trade License Fee can be charged per ring or item. If penalty is not paid, my stall allotment can be cancelled and stall rent may be forfeited.
10. If I have defaulted in paying Stall Rent/Premium/Electricity Charges/GHMC Trade License Fee of the previous years AIIE, I may not be permitted to participate in this year AIIE, until I clear the outstanding amount.
11. Stalls may be allotted/confirmed only after paying the full Stall Rent and Premium if any by me.
12. If there are any out standings against my stall, I assure to clear the dues before applying for the stalls to participate in the 85th AIIE.
